Damage Waivers

Damage Waiver:

A Damage Waiver will be charged on each invoice for all customers that have failed to meet Ameritemp Insurance Requirements. Damage Waiver fees will be deducted upon receipt of Evidence Insurance Requirements have been met.

What the Damage Waiver covers:

- Loss or theft of equipment. All loss or theft must be reported to police within 18 hours. A police report is required.
- Catastrophic damage to rental equipment. This applies to rental equipment that is damaged due to accident and has a repair cost over \$2500.00. Damaged equipment may be subject to additional rental charges until repairs are completed.

What the Damage Waiver does not cover:

- Loss or theft not reported within 18 hours of loss. Loss or theft without a written police report.
- Loss or damage due to negligence or abandonment.
- Damage due to wear, dirt, environment under client control, improper packaging and improper use. Damaged equipment may be subject to additional rental charges until repairs are completed.
- Loss of accessories, cables, adapters, and power cords.
- Equipment confiscated, seized or held by government or third party. Additional rental charges will be applied until the equipment is returned.
- Theft by employees of the renter or of people to whom the equipment is entrusted.
- Theft from an unlocked vehicle.
- Loss or damage due to declared or undeclared war or warlike action by a military force or government authority.
- Loss or damage due to terrorism that involves nuclear, pathogenic, poisonous biological or chemical materials.
- Loss or damage due to direct or indirect acts of terrorism.
 - It is recommended that customers insure equipment for full replacement cost (or maximum deductible of \$2500.00) when shipping equipment. Federal Express, UPS and couriers do not automatically insure equipment and many claim limits of under \$100.00. Loss or damage due to shipping not arranged by Ameritemp, Ltd. is the responsibility of the customer.
 - Damages due to equipment checked as luggage on commercial airlines are not covered.

Damage Waiver Client Deductible:

- For Loss or theft: the client deductible is 20% of the full replacement cost of the equipment up to the deductible of \$2500.00.
- For catastrophic damages: the client deductible is 20% the full repair cost including parts, labor and shipping up to the deductible of \$2500.00.
